

**VILLAGE OF MARCELIN
BYLAW NO. 08/2011**

A BYLAW OF THE VILLAGE OF MARCELIN TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER.

COUNCIL of the Village of Marcelin, in the Province of Saskatchewan, enacts as follows:

1. The charges to be paid by the water consumer whose water service has been turned on and for persons who own or occupy premises drained or that are by bylaw required to drain into the sewer shall be those set out in Schedule "1" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
2. Person obtaining water from the coin operated meter shall pay the Bulk Water Rates as set out in Schedule "1".
3. The infrastructure fees charged, in accordance with Schedule "1", shall be used for infrastructure repairs, additions or upgrades, and/or annual debt repayments and shall not be used for operational expenses. The infrastructure fees collected, less any infrastructure expenses, shall be placed in a reserve at the end of each fiscal period.
4. Accounts for water service and sewer service shall cover a period of two successive months, and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid by the last day of the month of which such accounts are rendered. If an account is not paid by the last day of the month in which the fees were billed, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of \$30 to cover the expenses of turning off the water and turning it on again; provided that if it is required to turn on the water service outside the employees' regular working hours, the fee shall be \$45.
5. A one time penalty of 8% will be added to all water and sewer accounts outstanding after thirty days from the date on which such accounts are rendered.
6. Bylaw No. 3/2010 is hereby repealed

THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on January 1, 2012 and upon approval being issued by the Local Government Committee.
