BYLAW NO. 08/2012

A BYLAW FOR THE CONTROL OF DOMESTIC WASTE AND OTHER REFUSE FOR THE TRANSFER STATION:

WHEREAS Saskatchewan Environment has issued a Permit to Operate a Transfer Station, Permit No. 00058362-00-00, on October 1, 2010:

NOW, THEREFORE, the Council of the Village of Marcelin, in the province of Saskatchewan enacts as follows:

1. In this Bylaw the following definitions shall apply:
 - a) **“Administrator”** means the Administrator of the Village of Marcelin;
 - b) **“Council”** means the Council of Village of Marcelin;
 - c) **“Domestic Waste”** means putrid animal, mineral and vegetable waste resulting from handling, preparing, cooking and consumption of food;
 - d) **“Liquid Domestic Waste”** means any waste which contains animal, mineral or vegetable matter in solution or suspension;
 - e) **“Refuse”** means wastes, including domestic waste, rubbish, street cleaning, and yard clipping, but not liquid domestic waste;
 - f) **“Bulk Refuse”** means wood, trees, shrubs, stumps, or branches;
 - g) **“Designated Area”** means separate sites within the Waste Disposal Site set aside for particular disposal, ex: domestic waste, rubbish, wood, and/or bulk refuse, metal;
 - h) **“Public Highway”** means a road allowance, road, street or lane, vested in Her Majesty or set aside for such purposes, and include the entry road to the Waste Disposal Ground, a bridge, culvert, drain or other public improvement erected upon or in connection with such public highway;
 - i) **“Whites”** means large metallic objects, such as major appliances, water heaters, stoves, furnaces, washers, dryers, refrigerators, deep freezers, dishwashers, bed springs, fencing, gates, etc;
 - j) **“Waste Disposal Ground”** means the Municipal Waste Disposal site located on all that portion of the South West Quarter of Section 4, Township 46, Range 6, West of the Third Meridian, Saskatchewan, 7.30 acres shown as Parcel A on Plan 85PA12605;
 - k) **“Waste Disposal Grounds Officer”** means the person designated by the Council of the Village of Marcelin or the employee hired by the Village of Marcelin to collect and dispose waste.
2. Whereas, a fence and gate has been installed previously, the Transfer Station Officer shall ensure that the gate remains locked at all times, unless supervision is provided for by the Transfer Station Officer.
3. No person shall place, dump or dispose of any domestic waste, refuse, whites, bulk refuse, etc. near or over the gate at the Transfer Station or on any public highway.
4. No person shall deface, destroy, or alter any signs, gates or fencing at the Transfer Station.
5. No person shall enter the Transfer Station without supervision or permission from the Transfer Station Officer.

6. All domestic waste, refuse, trees, bulk refuse, and whites shall be deposited in the designated areas of the Transfer Station.
7. All fees will be charged according to the schedule attached to and forming part of this bylaw
8. No person shall remove, disturb, or take away any material, object or thing from the Transfer Station without written permission from the Administrator. The Village of Marcelin shall own and have sole rights to dispose of all refuse collected and delivered to the Transfer Station.
9.
 - a) person who infringes any of the provisions of this Bylaw or fails to comply therewith shall be liable on summary conviction to a penalty of not less than \$250.00.
 - b) The imposition of such penalty for failure to comply with any of the provisions of this bylaw shall not relieve the person in default from carrying out the work therein mentioned.
10. Bylaw No. 03/2005 is hereby repealed.

BATTERIES (can be dropped off Desjardins Service, proceeds donated to Marcelin Volunteer Fire Department)
